Slip renters will continue to have access to their boats through 9th Ave N., but you will be required to pick up credentials ahead of the event to gain access to Riverfront as the entirety of Riverview Park will be closed off for the festival. PAYMENT/WAITING LIST:

Enclosed please find your combined contract and boater information worksheet, a copy of the rules and conditions, and your invoice which does include a 3% rate increase for the 2025 season. Please fill out any highlighted areas on the back side to ensure we receive your most updated information, as well as signing the contract and **RETURN** with your 25% down payment and/or your payment in full (to get the 5% discount). Also, please check to see your insurance is updated and take the time to read and take note of any changes/additions to our Rules & Conditions sheet.

If you're currently on the waiting list, be sure to sign your enclosed copy (if you haven't already) of your intention to remain on the waiting list along with your initial payment by Feb.1, 2025. The Blue Waiting List Form must be signed annually to remain on the list – NO EXCEPTIONS

- **IMPORTANT REMINDER:** To guarantee your existing slip, the enclosed application form, along with your initial non-refundable 25% down payment must be returned to the Ericksen Community Center, 1401 11th Ave. N. no later than **February 1, 2025**. You may choose to mail in your fee and signed contract or stop by the Ericksen Community Center Office. Office hours are Monday through Friday 8am – 5pm. Contact phone number is 563-243-1260. If no payment is made with the office by the February 1st date, we will consider your slip to be forfeited – No Exceptions.
 - Forfeited Slips will be assigned by Marina personnel according to waiting list.
- Payment in **FULL** must be made by **May 1, 2025**, or at the time of launch in April (whichever comes first). For your convenience, you may elect to do partial payments in increments of 25% between February 1, 2025 and May 1, 2025. 2025 Slip fees (and winter storage/haul-out fees) **MUST** be paid in full prior to launching your boat.
