PAYMENT:

Enclosed please find your combined contract and boater information worksheet, a copy of the rules and conditions, and your invoice for the 2026 season. Please fill out any highlighted areas on the backside to ensure we receive your most updated information, as well as signing the contract and return with your 25% down payment and/or your payment in full (by Feb. 2 to get the 5% discount). Also, please check to see your insurance is current and on file no later than **May 1st**. Please take the time to read and take note of any changes/additions to our Rules & Conditions sheet.

- **IMPORTANT REMINDER:** To guarantee your existing slip the enclosed application form, along with your initial non-refundable 25% down payment must be returned to the Ericksen Community Center, 1401 11th Ave. N. no later than **February 2, 2026**.

The down payment timeline will be enforced, so please plan accordingly. If payment is not received by the listed due dates, your slip will be made available. You are responsible for making certain that payment is received.

You may choose to mail in your fee and signed contract or stop by the Ericksen Community Center Office. Office hours are Monday through Friday 8am – 5pm. Contact phone number is 563-243-1260. If no payment is made with the office by the February 2nd date, we will consider your slip to be forfeited.

- Forfeited Slips will be assigned by Marina personnel according to waiting list.
- After the initial required down payment due Feb. 2nd, all other payments in full must be made by **May 1, 2026**, or at the time of launch in April (whichever comes first). For your convenience, you may elect to make partial payments in increments of 25% between February 2, 2026, and May 1, 2026. 2026 Slip fees (and winter storage/haul-out fees) must be paid in full, and current insurance on file prior to launching your boat.
- For your convenience, you can pay your slips fees IN FULL if you have an account setup with Rec Desk. For questions on how to set up an account, reach out to the Admin office at 563 243-1260.
